**TIME:** Warm Up: 7:30 - 8:00am. The 1000 Free will start promptly at 8:15am. All other events to start no earlier than 9:15am.

**LOCATION:** Lemont Park District's The CORE, 16028 127th St, Lemont, IL 60439

**ELIGIBILITY:** Must be over 18 years of age and a current USMS member. The ILSMA "Consolidated Entry Card" is to be used for designated events. "No Time" entries will be accepted. 500 Free will be limited to the first 20 swimmers to sign up. Deck entries open until 9:00am. The 1000 Free will be limited to the first 15 swimmers to sign up.

**FACILITY:** 25 yard indoor pool, electronic timing and display. The length of the competition course without a bulkhead is in compliance and on file with USMS in accordance with articles 105.1.7 and 107.2. This means that it is eligible for top 10 recognition. Lockers and showers available. Please bring your own lock and towel.

**CHECK IN, WARM UP AND AWARDS:** Entry to the facility will be available at 7:20am and warm up for the 1000 Free starts at 7:30am. There will be a 10 minute break after the 1000 Free. All competitors must check in before 9:00am. During the warm up period, there will be designated sprint lanes for the use of starting blocks. Ribbons will be awarded for all events 1st through 3rd place.

**FEES:** \$10.00 meet surcharge per swimmer. \$5.00 per event, limit 5 events per swimmer. Results will be posted on the internet. Make checks payable to: Tri Right. Deck entries will be allowed until 9:00am
